She provides spiritual guidance with the goal of assisting clients in finding a mindful balance within the mind and body.

The Holistic/Metaphysical Process

_____Reiki presents an opportunity to make an investment in personal growth, well-being and awareness within the context of a professional, helping relationship. Ms. Dimery will intake a personal history of your background to assist in understanding you as a unique and valued person. This intake will help in creating a service plan and clarifying your goals. Your commitment and personal involvement is vital to the healing or growth process. Your insight and feedback is encouraged along the way. Periodically, a review and evaluation of your progress will be discussed and your goals will be revised as needed.

_____Hypnosis is a modality that sets the mind and body in a deep state of relaxation. This approach allows the subconscious mind to obtain additional information in order to decrease or enhance a behavior or thought pattern the client is desiring. Hypnosis is a form of following directions and it is up to the client to accept or disregard suggestions. Hypnosis is used to modify behavior and thoughts.

_____Psychic Mentorship is provided to individuals or groups who are seeking additional training to enhance metaphysical abilities, guidance in understanding spiritual or paranormal events and experiences.

_____Spiritual Teaching is provided in workshops or classes to groups of people who are seeking to learn more about various metaphysical topics, to enhance their knowledge and gain hands-on learning.

_____ Psychic Mediumship is provided to those who are seeking to communicate with spirits located on different dimensions, deceased loved ones, or higher dimensional beings for person reasons.
